January 31, 2018 Meeting:

2. Treasurer Tom Post said we have \$2662.65 in the bank, not including recent fees from membership renewals. Tom also mentioned that he has paid the yearly non-profit corporation fee to the state of Illinois.
3. Kentley L. showed the latest version of the Membership Application form and explained why it is two pages long.
4. We needed to elect a new President after the death of Dave Hill. The subject of whether or not the club has by-laws regarding election of officers was brought up. As far as anyone present knew we do not have any by-laws, and no one volunteered to write any, so we proceeded with an election. Rex Grove volunteered to serve as President, and was elected by unanimous voice vote. Kentley Loewenstein volunteered to fill Rex's position as Secretary, and was also elected by voice vote.
5. Pete Crocker said that he will be a liaison between Boy Scout Troop 7 (Dave's troop) and Saukenuk Paddlers. Dave's family has given most of Dave's paddling stuff to the troop, but Pete said they will let Saukenuk borrow the boats and DVD's when needed for paddling events. Details will still need to be worked out. It is expected that Saukenuk will continue to work with the scouts on paddling events also.
6. A motion was made and approved to donate \$250 to the scout troop for a scholarship fund to allow scouts to participate in events which they might not be able to afford, as Dave had done.
